### NOTICE

#### **Gist of the Annual Performance Review (APR) and Fuel Cost Adjustment (FCA) Applications for 2019-20**

1. The Hiranmaye Energy Limited (H MEL) has submitted applications before the West Bengal Electricity Regulatory Commission (Commission) for Fuel Cost Adjustment (FCA) and Annual Performance Review (APR) for 2019-20 in respect of Unit 1 and Unit 2 of 3 x 150 MW generating station on 25.11.2025. The FCA application and APR application have been admitted by the Commission and a Gist was published in newspapers on 19.01.2026 inviting suggestions, objections and comments from stakeholders. No suggestion/objection/comment has been received by the Commission from any stakeholders within the stipulated date and time.
2. Subsequently, H MEL has submitted two Supplementary Petition to its FCA and APR applications on 17.02.2026 and 24.02.2026 by revising their Aggregate Revenue Requirement. Both the Supplementary Petition have been admitted by the Commission on 27.02.2026. The applications submitted on 25.11.2025, 17.02.2026 and 24.02.2026 are now collectively called as "FCA and APR application" of H MEL for the Financial Year 2019-20.
3. Gist of the FCA and APR applications is as follows:  
The FCA application is for approval of the net Fuel Cost of ₹ 1569.51 Lakh and the APR application is for approval of ₹ 57616.06 Lakh towards net fixed cost for the year 2019-20. H MEL seeks to recover the resultant revenue shortfall of ₹ 58052.97 Lakh.
4. 6. The objections and suggestions, if any, on the proposals contained in the application may be submitted at the office of the Commission mentioned above from 11 AM till 5 PM on all working days within twenty-one (21) days from the date of publication of this notice in the newspaper.
